

# 2023 LAW CLINIC

**Objectives**: EUVALWEB Law Clinic offers a three-year Specialisation Course on EU Cooperation on Justice and Home Affairs (JHA), which is one of the main areas of the EU accession process and concerns an issue of extreme political relevance for the EU. In the form of in-depth and practical exercises, the Law Clinic will take a more technical-scientific approach and offer in-depth teaching on European Union issues for future professionals specializing in cross-border issues that are increasingly in demand in the labour market.

**Activities**: the Law Clinic will consist of 36 hours of training courses that will take place one day a week

(usually on Friday from 2 p.m.) from March to May both in presence and on the online platform 'Microsoft Teams'.

Teaching: all clinic topics will be held by the Chair Holder, the Team Chair, academics, legal professionals, policy makers, civil society representatives and NGOs, including from the Western Balkans, with an interdisciplinary approach.

Target groups: undergraduate students, graduate, Ph.D. and Ph.D. candidates, legal practitioners, judges, lawyers, law enforcement, civil servants and civil society representatives, policy makers.

The **activities will concern four macro-areas** inherited from the 2019-2022 Jean Monet Module 'EUWEB', with an upgraded Area 4:
