#### Identity of the Chair

Co-funded by the European Union, the Jean Monnet Chair “*Promoting Public Awareness on Enlargement Policy, EU Values and the Western Balkans’ Accession*” (EUVALWEB) aims to promote the study of EU law among students, academics, practitioners and civil society. **The aim is to highlight and explain the important impact that the enlargement policy has in the construction of EU identity based on its founding values, as well as the strategy adopted towards the Western Balkans, in particular in the field of Justice and Home Affairs (JHA) cooperation, which is at the core of the legal system of the EU and its Member States, even beyond the territory of the EU.**

The EUVALWEB Chair enjoys the support of Albanian, Bosnian, Macedonian, Montenegrin and Serbian universities, as well as civil society and forensic associations that are directly involved in its activities, and the contribution of national and international experts. It is also sponsored by the Italian Ministry of Foreign Affairs and International Cooperation, which shares its objectives.

**The Chair’s research activity is conducted within the EUVALWEB Legal Observatory** in the following thematic areas: Cross-Border Security (Migration and Asylum Management); Combating Transnational Crime; Police and Judicial Cooperation; Promotion and Protection of EU Values and Fundamental Rights.

# ACTIVITIES

For the second edition the main educational, professional and scientific activities of the Jean Monnet Chair EUVALWEB, which will be led by the **Chair Holder and the Chair's Team, also with the participation of academics, policy-makers, practitioners, representatives of NGOs and civil society, students and student associations both Italian and foreign**, will be articulated:

- in a series of **Seminars to be held from November 2023 to May 2024**, conducted by the Chair Holder and the Chair Team, as well as by professors, practitioners, national and international experts, both in Italy and in one of the Western Balkan Countries.
- in a series of **Workshops to be held between November 2023 and June 2024**, conducted by the Chair Holder and Chair Team, as well as by professors, professionals, national and international experts, both in Italy and abroad, also with the active participation of students.
- in a main course (**Chair Course**) specifically set up as a **new didactic teaching course of the Department of Legal Sciences of the University of Salerno**, entitled **European Union Values, Integration and Migration Law** with the recognition of 8 ECTS.

- **Two legal clinics established as new practical courses in the training offer of the Department of Legal Sciences of the University of Salerno**, respectively:
  - ✓ **EU Cooperation on Justice and Home affairs: Knowledges, with the recognition of 2 ECTs (November - December 2023);**
  - ✓ **EU Cooperation on Justice and Home Affairs: Insights, with the recognition of 2 ECTs (April - May 2023).**
- **a series of conferences between the first and second semester of the academic year 2023/2024;**
- **a series of co-organised scientific initiatives** with other teaching courses of the Department of Legal Sciences and the Department of Management & Innovation Systems of the University of Salerno, some professional categories and with other Jean Monnet actions, as well as with student associations.
- **A cycle of 2 international conferences between May and June 2024**, under the leadership of the Chair Holder and the Chair Team, organised alternatively in Italy and in one of the Western Balkan Countries, with the aim of finding possible answers and strategies to the critical issues that emerged during the various activities.

All the above-mentioned initiatives will **encourage the active involvement of public opinion, professionals, policy-makers, experts in the field, NGOs and civil society**, promoting the dissemination of the activities of the EUVALWEB Chair in Italy and abroad.
