## Enlargement, Values and Integration into the EU

**Teacher:** Prof. Teresa Russo – EUVALWEB Chair Holder

**Tutors:** Dr. Stefano Busillo, Dr. Emanuele Vannata

**Semester:** Second

**Objectives:** The course aims to provide an in-depth and detailed understanding of the European integration process through the lens of enlargement and the development of the Union's identity based on the founding values. The course is divided into modules that will help trainees understand the internal and external challenges of enlargement, the benefits of closer integration, and the necessary reforms for the Union.

**Didactics:** The Course will be delivered through lectures, training seminars, workshops, simulations, and group projects that combine theoretical/practical and problem-solving approaches. It will take place three times per week from April to June.

It will be held as a stand-alone course by the Chair Holder, but it will be linked to other courses taught by the same Chair Holder to ensure the greatest possible participation.

The Course is organized in four (4) distinct Modules.

Seminars and intensive lectures, also in the framework of the EUVALWEB Legal Observatory, will be organized and held by the Team Chair and international and national legal experts. These will be open for public participation.

**Target:** Undergraduate students, graduates, Ph.D. and Ph.D. candidates, legal practitioners, judges, lawyers, law enforcement officials, civil servants and civil society representatives, policy makers.

**Workshop and final evaluation:** Trainees will work in small groups under the supervision of the Chair Holder and with the help of Tutors to develop papers in the form of questions and possible solutions. These will include key points for discussion and development at the international conference of 4 June. This will assess public perception of the European Union and opportunities for integration. The authors of the best papers will be asked to revise them into a scientific article for publication as an OER.

For its second edition the Chair Course will be organized in the following 4 modules.

**M1**

**Module 1: Enlargement as a Policy of the European Integration Process**

This module will examine enlargement in the context of the creation of the Communities and the Union, using the enlargement-development pair. Trainees will be asked to share their perspectives on the geographical, legal, and political boundaries of the Union's integration and enlargement process.

**M2**

**Module 2: Enlargement as a Policy to Promote Peace and Security in Europe**

This module will examine enlargement from a geopolitical standpoint, beginning with the Communities and ending with the Union of today. Trainees will be asked to share their opinions on issues concerning the Union's role and peacebuilding tools.

**M3**

**Module 3: Enlargement and Treaty Revision**

This module will examine the sustainability of enlargement in light of the changes implemented in the various accession processes, as well as the revision proposals currently being made by some member states and European institutions. Trainees will be asked to express their opinions on issues concerning treaty reform.

**M4**

**Module 4: Enlargement and the Future of the European Union: Values, Democratic Dimensions, and European Parliament Elections**

This module will look at the Union's values for protecting its legal order and identity, which are contributed to by all Member States and their citizens. Trainees will be asked to discuss the upcoming European Parliament elections and their role in strengthening the Union's democratic dimension.
