2024 LAW CLINICS

Objectives: EUVALWEB offers a three-year Specialisation Course on EU Cooperation on Justice and Home Affairs (JHA), which is one of the main areas of the EU accession process and concerns an issue of extreme political relevance for the EU. In the form of in-depth and practical exercises, the Law Clinics will take a more technical-scientific approach and offer in-depth teaching on European Union issues for future professionals specializing in cross-border issues that are increasingly in demand in the labour market.

Activities: Two legal clinics are established as new practical courses in the training offer of DSG UNISA. These are: 1) EU Cooperation on Justice and Home Affairs: Knowledges, with the recognition of 2 ECTs (November-December 2023); 2) EU Cooperation on Justice and Home Affairs: Insights, with the recognition of 2 ECTs (April-May 2024).

With the contribution of its Members, such activities fall into the dissemination activities of the EUVALWEB Legal Observatory and the review EUWEB Legal Essays. Global & International Perspectives.

Teaching: all clinic topics will be discussed by the Chair Holder, the Team Chair, academics, legal professionals, policy makers, civil society representatives and NGOs, including from the Western Balkans, with an interdisciplinary approach.

Target groups: undergraduate students, graduate, Ph.D. and Ph.D. candidates, legal practitioners, judges, lawyers, law enforcement, civil servants and civil society representatives, policy makers.
