1. Premise

The hereby document intends to showcase both the activities and results of the second edition (2023-2024) the Jean Monnet Chair in 'Promoting Public Awareness on Enlargement Policy, EU Values and the Western Balkans' Accession' (EUVALWEB), illustrating organizational aspects, such as social media engagement and usage, collaborations with other universities, institutes and Jean Monnet actions, composition of participants, and the proper outcomes/outputs ensuing from the Chair's efforts.

Co-funded by the European Commission, Jean Monnet Chairs are specialised teaching posts for university professors, aimed at deepening teaching and research in European Union studies and fostering dialogue between academia and society, both in the Member States and in other Countries. First presented to the audience in September 2022 and formally in November 2022, the Jean Monnet Chair EUVALWEB is the continuation and improvement of the Jean Monnet Module 'EU-Western Balkans Cooperation on Justice and Home Affairs' (EUWEB), active in the 2020-2022 period. The Chair is held by Prof. Teresa Russo, Associate Professor of European Union Law at the Department of Legal Sciences, University of Salerno, also responsible for the then Jean Monnet Module EUWEB.

The main goal of the Jean Monnet Chair EUVALWEB is highlighted and explained the important impact that the **EU Enlargement** policy has in the construction of EU identity based on its core values, as well as the EU strategy toward the Western Balkans, specifically in the field of Cooperation on Justice and Home Affairs (JHA), that is at the core of EU and Member States legal system, as well as beyond the EU's territory. To this end, alongside the Chair Holder, a gender-equal team of experienced and young advisors and trainers/teachers – the **Team Chair** – composed of national and international academics, policy-makers and professionals, carried out the teaching, research and dissemination activities envisaged in the Project.

In particular, building on the results achieved in the first edition, the **second edition** of the Jean Monnet Chair EUVALWEB intended to **revolutionise its offer** and further expand its didactic, scientific research and professional training activities, carrying out its initiatives throughout the academic year, both in Italy and abroad, in order to multiply the participation opportunities open to all categories of stakeholders; offer maximum dissemination of the activities and results achieved with the active involvement of public and civil society; further diversify activities in order to ensure the highest quality and topicality in the teaching of EU law.

For the second edition the main educational, professional and scientific activities were articulated, on one hand, in a course specifically set up as **a new didactic teaching course** of the Department of Legal Sciences of the University of Salerno, **entitled** '*European Union Values, Integration and Migration Law*' with the recognition of 8 (eight) ECTs.

Also, a series of activities instead took place in the EUVALWEB Chair Course convened within the EU Law course at the Department of Legal Sciences of the University of Salerno. On the other hand, two law clinics established as new practical courses in the training offer of the Department of Legal Sciences of the University of Salerno, respectively: 1) 'EU Cooperation on Justice and Home affairs: Knowledges', with the recognition of 2 ECTs



















































(November-December 2023); 2) '*EU Cooperation on Justice and Home Affairs: Insights*', with the recognition of 2 ECTs (April-May 2024).

The present report will, in the first instance, shed light on Digital support and deliverables (**Section 2**), explaining how the use of technology is critical to advertise and manage the activities of the Chair. Also, it will illustrate the status of partnerships and collaborations, with specific attention given to newborn agreements (**Section 3**). The report will take into account every activity carried out since late 2023 within the second edition of EUVALWEB (**Section 4**). The composition of the participants enrolled, and their feedback, will be under the spotlight too (**Section 5**). Conclusively, the report covers the research activities carried out within the Chair and its scientific results and publications (**Section 6**).

2. Digital support and deliverables

2.1 Logo and recognizability

EUVALWEB's logo represents the atom (from the Greek ἄτομος, átomos: indivisible) because the Union must be indivisible, translating an idea of unity, tolerance and cooperation in overcoming the differences, as values deeply endorsed by the Chair, which is more than ever required in the current tight situation throughout Europe. The logo comes as an evolution of the one from 2020-2022 EUWEB Module and is consistently employed in a number of activities "EUVALWEB branded', performed an advertising function in ours and our partners and supporters' events, similarly to those scientific publications. The use of EUVALWEB's logo was punctually combined with the EU's flag, proudly reminding the nature of the project and the support of the European Union, as well as with the Italian Ministry of Foreign Affairs and International Cooperation's logo, which has given its sponsorship to the Chair since the first edition.

2.2 Website & email service

2.3 Brochure(s), flyers and media coverage

Before the start of its activities, the Chair **presented its brochure in October 2023**, greatly useful to inform in a quick and intuitive way as many stakeholders and students as possible about the subject matters and topics of the course. Since the Chair activities were **divided in two programs (Course and Law clinics)**, **the second edition's brochure** was accordingly presented **in two distinct versions**, presented both digital and printed and disseminated through distribution to student associations, courts, public offices, as well as through social media and an extensive direct mailing towards our partners, supporters and speakers. Hence the Chair activities were introduced, respectively, in the **Chair Course's leaflet (EN)(IT)** and in the **Law Clinics' leaflet (EN)(IT)**.

Events' **flyers** have been sent via email to the attendees of the Chair Course or the Law clinics in order to present the whereabouts of the highlighted activity. **Diversification of flyers** has been deemed suitable for the stratified audience of the Chair, entailing different versions for: **Seminars, Conferences, Workshops** and **Special Events**.













creating and then developing a true community with our participants, as well as catching the attention of those who perhaps did not know about the Chair's activities.

3. Chair's Network and Collaboration Initiatives

3.1 'A Network of Security' in Europe with National Association of Magistrates, the Italian Postal Police, the Giffoni Experience Autonomous Body



















































During the Chair's second edition, the EUVALWEB Chair launched a project 'A Network of Security' in collaboration with the **National Association of Magistrates** – Salerno District Section, the **Italian Postal Police**, the **Giffoni Experience Autonomous Body** and the **Bar Association of Salerno**.

The **goal of the project** is to promote, on an international level, a digital education that respects people's fundamental rights, highlighting, particularly for younger generations, the criminal implications of social network use and fostering the exchange of best practices and skills in the field of criminal judicial cooperation between operators.

The project has so far led to convening a series of events in Romania in April 2024, namely a mock trial on the subject of sextortion and a bilateral meeting between Italian and Romanian judicial authorities for the exchange of best practices and skills in the field of criminal judicial cooperation. Additionally, also as part of the program of the fifty-fourth edition of the Giffoni Film Festival (July 2024), a special event on Cinema and Law was organized in order to raise awareness among young people of the proper use of social media, crime prevention, and knowledge of the law.

3.2 Team Chair

The EUVALWEB Chair promoted innovation in teaching and research through cross-sectorial and multi-disciplinary studies, open education, networking with other public and private institutions. 3.5 Supporters

As anticipated (Section 3.1), the **project** 'A Network of Security' in Europe allowed the Chair to start scientific and social initiatives with the Giffoni Film Festival, directly involving Dr. Jacopo Gubitosi, General Director Giffoni Film Festival, and Dr. Elena Scisci, Artistic Direction Giffoni Film Festival.

The idea of the project was born also in cooperation with the **Salerno Bar Association Council**, testifying the commitment by the Chair in training practitioners under every aspect of their job and **consolidating a long-standing cooperation** between the Chair and the Association. Moreover, the latter granted the **recognition of professional credits** during the year, namely for the events of 21 March 2024 (Workshop) and 22 March 2024 (Seminar).

4. Activities

The Jean Monnet Chair EUVALWEB was conceived as a fundamental teaching course and a highly specialized training course addressed to students, graduates, PhDs and PhD candidates, but also to all private and public stakeholders in the field of justice and home affairs, such as lawyers, policemen, public administration employees, etc. Due to the diversification of targets, EUVALWEB opted to distinguish its activities in two different programs, the Chair Course and the Law clinics.

4.1 European Union Values, Integration and Migration Law

The 'European Union Values, Integration and Migration Law' course was instituted in 2023 as a supplementary compulsory subject in the 5-years unique curriculum available at the Department of Legal Sciences (School of Law) of the University of Salerno.

The course is set for **72 hours** in the **Second Semester** (February-June 2024) and grants **8 (eight) ECTs** in case of a successful final exam. Inserted in the IUS/14 of the academic fields and disciplines list, this teaching aims to provide students with an in-depth **knowledge** of European Union **policies concerning the promotion and safeguarding of common values, integration and immigration and asylum**.



















































It relies on the explanation of **regulatory instruments and strategies** developed by the **European Union** in relation to the **accession of new Member States**, with specific reference to the requirements concerning the **control of external and internal borders** and the **conditions of entry and stay in the union of foreigners**, measures to combat irregular immigration, the treaty of human beings and the EU asylum and international protection system and regular migration, in the context of the construction of a European Area of security and justice founded on respect for and promotion of common values.

4.2 EUVALWEB Chair Course

The <u>EUVALWEB Chair Course</u> 'Enlargement, Values and Integration into the EU' was intended to target, above all undergraduate students, and secondly graduates, Ph.D. and Ph.D. candidates, legal operators, judges, lawyers, law enforcement officials, civil servants and civil society representatives, policy makers. Held in the **Second Semester** at the **Department of Legal Sciences (School of Law) of the University of Salerno**, the Chair Course **lasted from April 2024** to **June 2024**. The activities were carried out **in presence**.

As a stand-alone course by the Chair Holder, it was linked to other courses taught by the same Chair Holder to ensure the greatest possible participation. This was managed in particular with respect to the course of EU Law.

The scientific direction of the EUVALWEB Chair Course was in the hands of the Chair Holder, Prof. Teresa Russo, assisted by the Chair Course Tutors, Dr. Stefano Busillo and Dr. Emanuele Vannata. The course aimed to provide an in-depth and detailed understanding of the European integration process through the lens of enlargement and the development of the Union's identity based on the founding values. It took place in the form of Lectures, Seminars, Conferences and Workshops, with theoretical/practical and problem-solving approaches.

The workshops were intended to be the finalization of each of the four (4) distinct modules in which the Chair Course was organized into, as specified below:

During the Course, **trainees**, divided into small groups, under the supervision of the Chair Holder and with the support of Tutors, **carried out interactive workshops** for the elaboration of **papers** in the form of **questions** and possible solutions, then discussed at the first closing conference of the Chair. **Students** from the **workgroups** were asked to study topics of their selection in order to **showcase their knowledge** in the **second final**



















































Conference of 4 June 2024. They were also tasked to include critical remarks in the form of queries so that their questions could be properly addressed in the same Conference. This was to assess public perception of the European Union and opportunities for integration.

4.3 Law Clinics

In 2023, **two law clinics established as new practical courses** yearly available in the training offer of the Department of Legal Sciences of the University of Salerno. Both clinics are qualified as **lab activities** in the 5-years unique curriculum of the Department and do **grant 2 ECTs**.

The EUVALWEB Law Clinic '<u>EU Cooperation on Justice and Home Affairs:</u> <u>Knowledges'</u> takes place in the First Semester and intends that the students acquire the basic knowledge of the current European area of freedom, security and justice with a



















































practical approach related to the origins of cooperation and its evolution up to its formalisation in treaties as well as the different forms of integration and cooperation. It also covers the EU policies on border controls, asylum and immigration, judicial cooperation in civil and criminal matters and police cooperation.

The EUVALWEB Law Clinic 'EU Cooperation on Justice and Home Affairs: Insights' takes place in the Second Semester and aims to deepen the characterising elements of the European Union's cooperation on justice and home affairs. It provides students with advanced knowledge and insights concerning the current area of freedom, security and justice, with a practical specifically dedicated to the study of cross-border security issues, the fight against transnational crime, of police and judicial cooperation, the promotion of the union's values and the protection of fundamental rights.

The activities were held by the Chair Holder, academics, legal professionals, policy makers, civil society representatives and NGOs. Differently from the Chair Course, the Law clinics also **offered in-depth teaching** on European Union **issues for future professionals** specializing in cross-border issues that are increasingly in **demand in the labour market**. The final selection of topics included: immigration, cross-border security, combating transnational crime, police and judicial cooperation, and the promotion and protection of EU values and fundamental rights.

The Law clinics sported some **Focuses** on specific areas as "other activities" distinct from Conferences, Seminars and Workshops.

4.4. Conferences, Seminars, Workshops & Other Activities

Conferences referred to a large formal typically involved a larger gathering of participants, covering a **broad and diverse range of topics**, often from different disciplines. Their type of work was based on, first, presentation and, second, debate/exchange of views. The consultative nature of the Conferences made them the natural venue to further the research and find solutions to the prospected problems.

In its second edition EUVALWEB hosted a total of 7 Conferences.

On 13 November 2023, our newly acquired partner, the Institute of Sociological and Criminological Research of Belgrade, hosted the Seminar 'International and European Cooperation in Criminal Justice', also officially announcing the partnership. The following day, on 14 November 2023, the Institute of Comparative Law of Belgrade and the University of Criminal Investigation and Police Studies of Belgrade also hosted operational meetings with the Chair Holder, Prof. Teresa Russo.



















































The agenda of November 2023 saw the EUVALWEB Chair Holder, Prof. **Teresa Russo**, attending a **bilateral meeting** and a **gala** at the Italian Embassy in Belgrade (Serbia), as **guest** of the **Italian Ambassador**, **H.E. Dr. Luca Gori**.

Furthermore, the strong degree of cooperation with our Serbian partners comes by the fact that the first Final Conference in Belgrade, of 30 May 2024, was co-organized with the Institute of Comparative Law of Belgrade (Serbia), the Institute of Sociological and Criminological Research of Belgrade (Serbia) and the University of Criminal Investigation and Police Studies of Belgrade (Serbia), which also served as the venue for the event.

Anticipated by a <u>Call for Papers</u>, this conference was intended to serve as a **forum for discussion** and comparison of the steps taken and yet to be taken to bring the legal systems of the accession states into line with the criteria of EU membership, as well as to discuss cooperation between judicial and law enforcement authorities within the European area of freedom, security and justice in order to effectively and efficiently combat the pervasive problems of transnational crime, thereby forming a common platform of intentions and objectives to strengthen judicial cooperation and internal affairs in preparation for EU accession.

EUVALWEB has also successfully convened scientific and dissemination event to raise awareness with the Faculty of Law of the University 'Titu Maiorescu' of Bucharest (Romania). On 16 April 2024, a Seminar entitled 'EU Values and Gender Equality' was coorganized and hosted by the Faculty of Law of the University 'Titu Maiorescu' of Bucharest (Romania), in the person of Prof. Marieta Safta. The Faculty provided dissemination of the event. The topic was selected by looking at the values and goals of the European Union where women and men, in all their diversity, are free to pursue their chosen path in life, have equal opportunities to thrive, and can equally participate in and lead the European society. The Seminar was also an opportunity to introduce and disseminate the activities of the Chair to an audience composed of both students and representatives of the Romanian academic community as well.

On <u>17 April 2024</u> the Italian International School "Aldo Moro" of Bucharest (Romania), within the framework of the project "A Network of Security" in Europe" hosted a mock trial on sextortion. This was particularly meaningful as mock trials and simulated investigations allow participants to analyze the various manifestations of the crime, as well as the many complexities and challenges surrounding the investigation, prosecution and adjudication of trafficking cases. In the afternoon of the same day, the international conference "The Status of Criminal Judicial Cooperation between Italy and Romania: Problems and Suggestions" was hosted at the General Office of the High Court of Cassation and Justice in Bucharest. The Conference, with the participation of H.E. Mr. Alfredo Durante Mangoni (Ambassador of Italy in Bucharest) and under the coordination of Dr. Fulvio Baldi (Deputy General Prosecutor at the Italian Court of Cassation, Member of the EUVALWEB Legal Observatory) was finalized, in a bilateral set-up, to the exchange of best practices and skills in the field of criminal judicial cooperation between operators.



















































In addition, in <u>February 2024</u>, as a Teaching Staff Member of the Jean Monnet Chair **ProsoEUlaw**, Prof. Teresa Russo held a lecture on the topic of '*Upholding and Promoting EU Values in Candidates Countries*' in the framework of the **Winter School** '*Reinforcing EU Responsible Global Leadership. 5. Participants' composition, feedback, credits and certifications

5.1 Composition

Participating to any of the Chair's activities was **free of charge** and participants **needed only to register** on the Home Page of the **website** 'https://euvalweb.euweb.org/', by clicking the **registration button**, **alternatively or cumulatively, for the Chair Course or a Law**



















































Clinic. For the **Law clinics**, participation in a **single** (or more than one) **event (Conference)** was likewise permitted through registration on the website. The acknowledgement of credits and certifications for both students and professionals were directly related to the chosen activity.

Attendance was recorded during the events, asking the attendees to sign twice, at the moment of their arrival and before leaving. Attendance recording was key in order to assert if an attendee would be eligible to earn credits or the final certificate of attendance. These were granted to each participant that attended at least 70% of the total lectures of the Chair Course or 50% and a written test in the Law Clinics. The events were open to the participation of everyone interested, with no particular requirements for the registration or, eventually, no need for registration to attend the event. Also, the Chair adopted a flexible approach in providing the possibility of participation to single events to those who purposely registered for them.

















Chair Course's overall assessment. (ratings from 1 = very bad, to 5 = very good)



Law Clinic: Knowledges' overall assessment. (ratings from 1 = very bad, to 5 = very good)





















































Law Clinic: Insights' overall assessment. (ratings from 1 = very bad, to 5 = very good)















Feedback on the Chair Course's capability to raise awareness on the EU. (ratings from 1 = very bad, to 5 = very good)

5.3 ECTs for students, credits for practitioners and certificates

In both the Law Clinics, in order to gain 2 (two) ECTs, all the enrolled ungraduated students were invited to submit a final test on the topics covered during the training activities of the Clinics themselves.

Foreign students on ICM or Erasmus+ mobility, who attended the Law clinics or the Chair Course and submitted a final paper, subject to evaluation by the Team Chair, were granted the number of 6 (six) ECTs. For instance, this happened with two Greek students who not



















































only presented a paper each, but were also invited to showcase it at the second Final Conference of 4 June 2024 in order to stimulate a debate with the discussants of the day.

Students enrolled in the exam 'European Union Values, Integration and Migration Law' that successfully took the exam were recognized of 8 (eight) ECTs.

Lawyers participating in the activities of the **Law clinic** were awarded a number of professional training credits (CFP) by the Salerno Bar Association Council for each study day. The **remaining stakeholders** updated their training and professional background with the **recognition of professional training credits.**

As anticipated, to whom achieved 70% (Chair Course) or 50% (Law Clinics) of attendance was awarded a certificate.

6. Research and publications

6.1 Joint Issue with Studia Iuridica Montenegrina

In January 2024, EUWEB Legal Essays. Global & International Perspectives published Issue 1/2024 as a joint special issue with the journal Studia luridica Montenegrina. The special issue served as an important publication to illustrate the outcomes achieved so far and was the occasion to showcase some of the papers by scholars, experts, and professionals that took part to the Conclusive Conference 'Promoting Public Awareness on Enlargement, EU Values and the Western Balkans' Accession' of the First Edition that took place at the Faculty of Law of the University of Donja Gorica of Podgorica, Montenegro, on June 20, 2023.

The reading offers both academic and professional analysis and considerations of important issues in the **fight against transnational organised crime**. On one hand, the **cooperation** of the **University of Salerno and the University of Donja Gorica**, through the project supported by the European Union, was an academic answer to existing challenges by promoting dialogue, education, public awareness, and contributing to the realisation of the



















































rule of law. At the same time, on the other hand, the cooperation between EUWEB Legal Essays and Studia Iuridica Montenegrina, in publishing this joint effort, was an expression of a shared social investment in fighting against organised crime, as 'responsibility of every authority and the duty of the whole society' in the words of Dr. Ivana Jelić, Judge of the European Court of Human Rights and author of the foreword.

6.2 Book: 'Allargamento e Membership'

The monograph 'Allargamento e Membership' (EN: Enlargement and Membership), by the Chair Holder, Prof. Teresa Russo, aims to provide an overview of the European Union's enlargement policy and how it has affected its membership.

The work analyzes the **systematic role of enlargement policy** in the legal order of the Union (**Chapter I**), after which it looks at the **regulatory bases** and application practices that have helped to identify the **conditions of membership** (**Chapter II**). The work begins with the **various accession processes**, which explain the motivations behind this research (**Introduction**). However, the latter draws attention to a **difference between preand post-enlargement** that the Court of Justice similarly denounced, demanding adherence to Article 2 TEU as the cornerstone of the Union's and its members' identity (**Chapter III**). In conclusion, the book evaluates potential enlargement options that combine treaty reform and accession, based on suggestions made by some European institutions and Member States (**Chapter IV**).

Published by Editoriale Scientifica, the book can be seen as the product of scientific research conducted within the Jean Monnet Module 'EU-Western Balkans Cooperation on Justice and Home Affairs' (EUWEB, 2019-2022) and the Jean Monnet Chair 'Promoting Public Awareness on Enlargement Policy, EU Values and the Western Balkans' Accession' (EUVALWEB, 2022-2025).

6.3 EUVALWEB Legal Observatory and Young Observers

Deepening the cooperation with our Western Balkans Partners and widening the spectrum of scientific collaborations to other academic *fora*, the **EUVALWEB Legal Observatory** builds directly on the experience of the 'EUWEB Legal Observatory', which is linked to the activities of the 2019-2022 Jean Monnet Module '*EU-Western Balkans Cooperation Justice and Home Affairs*' (EUWEB).

The Observatory's current configuration **broadens its research area**, adapting to the needs of the Chair. Overall, the body <u>Members</u> share the purpose of enhancing collaboration and research in broadly **defined areas** of migration, fight against transnational crimes, police/judicial cooperation and EU values & Fundamental rights. Among the goals of the Observatory, it is fair to stress the **commitment** to **identify evolving trends** in the field of EU cooperation on **justice and home affairs** as well as to **raise awareness** of national, international and European **policies** to ensure security and respect for the rule of law, democracy and human rights at national and international level. In order to aptly carry out



















































their <u>activities</u>, during the second edition of the Chair, the Members of EUVALWEB Legal Observatory met periodically to update about their research work and developments in International Law and EU Law.

In perseverance of our **bottom-up approach**, existent since the EUWEB Module, the Chair **temporarily included students** in the Legal Observatory, granting them the status of **Young Observers** – led by a **Supervisor**, **Elisabetta Lambiase**.

The **2024 line-up** consisted of five members (alphabetical order):

The Young Observers were accordingly selected to conduct research of documents, sources and judgements as well as the elaboration of original work undertaken primarily to acquire new knowledge with a specific application in view. They were also included in the activities of the Chair, such as taking part in the stewardship of the conferences as well as the reception of the guests and the management and support of the audience during the open debates. On top of that, as anticipated, the Young Observers were invited to update the audience on the latest developments in the second final Conference of 4 June 2024, as well as to take part the inaugural lecture of the Chair Course of 22 April 2024.

6.4 EUWEB Legal Essays. Global & International Perspectives

EUWEB Legal Essays. Global & International Perspectives (ISSN: 2785-5228) was **born in 2022** from the then EUWEB research group's desire to make the most of and build on the scientific results achieved within the 2019-2022 **Module "EUWEB**". In addition, the Journal seeks to **disseminate the research conducted**, **at this time**, by the **EUVALWEB Legal Observatory** on a platform promoting the scientific work of scholars, practitioners, and stakeholders in the fields of EU and International Law, particularly in the relationship with the Western Balkans. The Journal, in full respect of its Ethical Code and Anti plagiarism Policy, **publishes two online issues per year** (winter and summer) of articles exploring particularly the external dimension of immigration, the fight against transnational crime, judicial and police cooperation, and the protection of fundamental rights, promoting a multidisciplinary approach in legal studies. EUWEB Legal Essays boasts some features, such as being:



















































- **Open access:** to guarantee the widest possible readership, the articles are available free of charge on the Journal's website.
- Peer-reviewed: submissions undergo rigorous double-blind peer reviews by the Reviewing Committee that includes highly qualified members of the world's scientific community.

- **Multilingual**: committed to promoting linguistic diversity by publishing articles in English, French, Italian, and Spanish.

6.5 Bulletin

The Young Observers were entrusted with the periodic publication of our Bulletin, which provides clear insights into the current status of legislative and operative processes regarding the thematic areas covered by the EUVALWEB Observatory. Giving out concise EU-related bundle information on legislative files or topics, the Bulletin publishers tried to act in a way to easily have the readers updated.

Bilingual news (EN/IT) are duly released in order to keep the **audience aware** of the **developments on key issues and policy areas** that have the potential to feature prominently in **public debate** and on the **political agenda of the European Union** over the coming years. In particular, the Bulletin was **keen on tracking the record of crisis management** on the major emergencies of the year, covering the Ukraine and the migration crises.

The Bulletin is available on EUVALWEB's website (Open Resources) and is **edited** by the **Young Observers** with the **aid of their supervisor** with a precise assignment of the topics to look out:

In the first place, EUVALWEB provided a set of <u>Didactic Materials</u> for both the <u>Chair Course</u> and the <u>Law Clinics</u>. The Chair envisaged its Didactic Materials as <u>wide variety</u> of educational resources and tools of subject-specific nature that are used as learning aids. Their mission is to ultimately <u>clarify</u> the <u>contents</u> and to achieve a <u>deep and meaningful understanding</u>. Out of users' choice, they <u>may represent auxiliary resources</u> that accompanied the speaker's explanations, in the case of <u>Seminars</u>, <u>Conferences and Workshops</u>, <u>or</u> as the <u>main resource</u> where to find <u>all the contents to be learned</u> on that occasion, as happened for the <u>Modules of the Chair Course</u>. As an example of variety of the Materials, the user may inspect the aforementioned <u>reports</u> from the <u>Young Observers</u> within the <u>EUVALWEB Observatory</u> as well as the <u>Proceedings</u>

Other periodically updated open resources provided to the audience by the Chair, such as the Bulletin, are the so-called essential references. In particular, keeping up to date with the current and future status of the Caselaw is key in delivering the most up-to-date education. Courts' decisions can affect everything from the European States (requiring them to adjust a certain policy), the institutions of International Organizations or even individuals. Hence, Caselaw references become a complementary tool for the correct understanding of the topics covered by the Chair. Similarly, legal doctrine sets the terms for future resolution of cases in an area and not seldom offers to rationalize what the courts or the legislator finds unclear. In addition, scholars rely upon a communication formula that is purposefully meant to "teach" or "inform" the reader. For these reasons, Bibliographical references were included in the resources intended to aid the learners.
