Biography

SARA POLI is Full Professor of European Union Law at the Department of Political Science of the University of Pisa; she has been visiting professor at LUISS Carli in 2024-2025. Previously, she has worked as researcher at the Faculty of Law of the University of Rome Tor Vergata and as Adjunct Professor at the Faculty of Law of the University of Trieste. She was awarded a Jean Monnet Chair by the European Commission in 2013-2016 and one on the enlargement of the Union and the rule of law (2025-2028). She has been a Marie Curie fellow at the Department of law of the European University Institute in Fiesole (2008-2009) where she has also been visiting professor in 2023; in the same institution she has been a Jean Monnet Fellow (2002-2003). Professor Poli has worked as a lecturer in European Union Law at the Department of Law of the University of Southampton (United Kingdom) and as an assistant in the Department of Law of the College of Europe in Bruges (Belgium) from 1999 to 2001. From the same College he received a diploma in European Legal Studies (1998-1999). She completed her postgraduate degree at the Scuola Superiore di Studi Universitari e Perfezionamento S. Anna (SSSA) in Pisa in 2000 where she also did her undergraduate studies. She has published several books including one on restrictive measures (2019) and one on the External Action of the European Union (2021), written with M.E Bartoloni and numerous essays and articles in renowned journals of EU law. She has recently co-edited a book with S Marini on the EU on the international arena. Internal and external challenges and transformations. A co-authored book on the the EU's response to the war in Ukraine and its impact on the EU legal order is forthcoming.

CHRISTOPHE HILLION is Professor of European law at the University of Oslo and Visiting Professor at the College of Europe. His research focuses on EU constitutional law and external action. He currently coordinates a project on the Enforcement of the Rule of Law in the EU (ENROL) financed by the Norwegian Research Council.



Abstract

Making a Success of Enlargement – Some Candid Considerations

In the years preceding Russia's full-scale invasion of Ukraine, the prospect of additional states joining the EU had faded. The EU's deliberate downgrading of its enlargement policy after the 2004–2007 admissions, and its increased capture by some Member States' domestic interests, contributed to slowing down the applicants' already sluggish membership preparations. The EU capacity to transform candidates into full-fledged members thereby weakened, in turn deepening the scepticism within the Union towards further expansion. To break the vicious circle and make a success of an enlargement which they now frame as a 'geo-strategic investment in peace, security, stability and prosperity', the EU and its Member States ought to engage at three levels. First, the fundamentals of membership must be restored and consistently defended. Second, persistent impediments to the effective implementation of the enlargement policy must be addressed. Third, able candidates must be firmly anchored in the EU governance, *prior* to their accession.

Biography

MARCO EVOLA is an Associate Professor of European Union Law and EU Media Law LUMSA Department of Law, Economics and Communication, Palermo. He has been teaching European Union Law, European Union Private International Law, EU Media Law, Human Rights, European Migration Law. He was a member of different research groups within the framework of projects of research of national and international interest. He is professor in Master and post-lauream courses. He is a member of the Editorial Board of the review *Diritti umani e diritto internazionale* and Member of the Scientific Committee of the reviews *La Magistratura* and *International Journal of Law and Society*. He is a member of the Committee of Referees of the Review *Unione europea e diritti*. Member of the Doctoral Programme Committee "Mediterranean Studies. History. Law and Economics". His scientific research focuses on human rights, migration, accession to and withdrawal from the EU, Rule of law, gender discrimination.



Abstract

Enlargement in Time of War Between Change and Continuity

The decisions of the European Union to confer upon Ukraine the status of candidate to membership and the following choice to open the negotiations for accession are a turning point in the history of the process of European integration. For the first time since the setting up of the European Communities enlargement covers a state that is waging war as a consequence of the invasion of its territory. A series of challenges are embedded in this scenario affecting the policy on enlargement and the admission proceeding. The analysis aims at understanding the impact of war on the EU policy towards states aspiring to join the club and the way in which the Union is shaping enlargement to face the challenges flowing from this new situation. The fast advancement of Ukraine in the path towards admission originates from the watering down of the criteria the EU makes use of in assessing third-countries compliance with the accession conditions. However, a more profound change seems to take place within the framework of the proceeding as a consequence of the substantial removal of some of those conditions. But the process of reform is not so straightforward as it might appear at first sight because changes are taking place within a general framework which seems to be marked by continuity with the previous rounds of admissions thus giving rise to a series of problems on the relationship between war and enlargement that will be assessed.

Alessandro Petti, Assistant Professor in EU Law, Bocconi University Milan

Biography

ALESSANDRO PETTI is a legal scholar with an interdisciplinary background. His work is devoted to the study of the European Union and its laws. He is interested in investigating how the substantive development of EU law shapes the constitutional underpinnings of the Union and its posture as an international legal actor. He has significant expertise in the law of the EU's proximity policies. Alessandro has been Fellow at the Scuola Superiore Meridionale in Naples, at the Centre for European Law at the University of Oslo, and Max Weber Fellow at the European University Institute in Florence, where he completed his LLM in Comparative, European and International Laws. He holds a PhD in Law from Sciences Po Paris and an MA from the College of Europe in Bruges. He has been Blue Book Trainee at the European Commission in Brussels. He has designed and taught courses on EU law, EU

law and diplomacy, the law of the European Neighbourhood Policy, and EU external relations law.

Abstract

Wider Europe as an Analytical Concept

The current geopolitical turmoil urges a reappraisal of the law of the EU's proximity policies. In that light, *Wider Europe* can be turned into an analytical concept to capture the legal and political facets of the extension of the EU's legal space in the Union's neighbourhood. The presentation introduces three lines of inquiry. Firstly, it reflects on the similarities and differences between internal and external integration, drawing a distinction between EU membership law and EU neighbourhood law. Secondly, it unravels the techniques for the extension of the EU's legal space across different partnerships in the Union's neighbourhood. Thirdly, it sheds light on the political covenants underlying the variety of institutional arrangements of the extended EU's legal space. The presentation discusses how EU neighbourhood law entails a reconfiguration of how sovereignty is exercised both in the EU and in third countries participating in the *Wider Europe*.

MARIA EUGENIA BARTOLONI is a full Professor of European Union Law at the Faculty of Law, Sapienza University of Rome, where she teaches *European Union Law* and *Internal Market Law*. She is also Member of the Doctoral Board in "Public Law" (Department of Legal and Economic Studies, Faculty of Law, Sapienza University of Rome). She has been the Principal Investigator of the Research Project Unit "Rediscovering European Integration through Legal Storytelling (REILS)" - PRIN 2022; the Principal Investigator of the European Project *SELECT – StrEnghten Lay and honorary judges European CompeTencies* (JUST-JTRA-EJTR-AG-2020, Type of action: JUST-AG) and the Principal Investigator of the Research Project Unit *PIONEER -The Production of Law in Epidemiological Emergencies. Process Innovations to Increase Adherence to the Rule of Law and Performance*, FISR 2020 "Risposta all'emergenza, sviluppando soluzioni relative alla fase di espansione della pandemia". She has been a Visiting Professor at the East China University of Political Science and Law – Shanghai, China, (1-15 December 2019), (15-31 January 2023); Marie Curie Fellow at the East China University of Political Science and Law – Shanghai, China (27/04 2015– 11/05/2015); a Visiting Professor at the Uniwersytet Wrocławski under the Erasmus+ International Credit Mobility (March 2015); a Visiting Professor at the Universitat Autònoma de Barcelona under the Erasmus+ International Credit Mobility (November 2014); a Visiting Researcher at the Université Saint-Louis- Bruxelles (01-08-1998/31-03-1999). She is also Co-Editor of the Book Series "*Studi di Diritto internazionale e dell'Unione europea – Studies in International and EU Law*" – Wolters Kluwer, Scientific Committee Member of "*Rassegna di Diritto pubblico europeo*" and of "*Jus*", Referees Committee Member of "*Studi sull'integrazione europea*" and Co-director of the Editorial Board of "*Il Diritto dell'Unione europea*". She has been a speaker at several conferences in Italy and abroad and author of over ninety publications (monographs, co-edited works, book chapters, academic journal articles (class A)).

Biography

CRISTINA CONTARTESE (MA University of Birmingham; PhD University of Bologna-University of Strasbourg) is an Assistant Professor in EU Law at the University of Campania, Luigi Vanvitelli. Previously, she was Lecturer in EU Law at the Hague University of Applied Sciences, and Lecturer in EU and International Law at the European Law and Governance School/European Public Law Organization (Athens). She held positions as a Postdoctoral researcher at the University of Bologna, where she taught International Law, and at the University of Luxembourg (Marie Curie fellow/FNR-Luxembourg), where she researched on dispute settlement mechanisms from EU and International Law perspectives. She was a visiting researcher at the Max Planck Institute–Luxembourg, and at the iCourts Centre (University of Copenhagen). Her main research interests include: EU Constitutional Law, EU External Relations, International Dispute Settlement, International Water Law, and the European Convention on Human Rights. She published on these subjects in edited books and peer-reviewed journals, such as *Common Market Law Review*, *Rivista di Diritto Internazionale* and *Legal Working Papers of the European Central Bank*. She is an analyst for 'EU Law Live Blog', and a member of the editorial board of *La Comunità internazionale*, *European Papers*, and *International Journal of Human Rights and Constitutional Studies* (IJHRCS).

Biography

Anna Pau currently holds a position of postdoctoral research fellow in EU law at the Department of Legal Studies of the University of Bologna. She obtained her PhD in EU law in July 2023 from the University of Pisa. The focus of her research is in the external relations law of the European Union, in particular the consistency of the EU external action with international law in selected case studies. In her thesis, she has focused on the EU treaty practice with some of its neighbours and on the related implications for contested territories, with particular regard to peoples' self-determination. She has also conducted research on topics such as EU disaster law, energy security, restrictive measures, solidarity in the CFSP, EU diplomacy, as well as on the EU case law on counter-terrorism; on the effective judicial protection of individuals subject to EU restrictive measures; on the promotion of values and principles in the EU external relations. The above is supported by her participation as a speaker in international conferences and workshops, as well as by the publication of contributions in peer reviewed journals and scientific volumes. She has also been member of the Jean Monnet networks EUDIPLO (The European Union in International Diplomatic Relations) and EUCTER (Research-led Excellence Network on EU Counter-Terrorism), as part of the team of the University of Pisa.

Kosovo submitted an application for EU membership in December 2022. This third country is considered a potential candidate, but not a full candidate like other European countries: the lack of recognition by five EU member states poses a

significant obstacle to its accession. Despite this, the EU engages with Kosovo in several ways, including granting it a “European perspective”, in open contrast to the position of its members which do not recognise Kosovo as a sovereign State. Although the Union enjoys full international legal personality, its status as an international organisation prevents it from recognising new States. Its action may nevertheless consist of defining criteria that its members are invited to follow in the recognition process and/or promoting a common position on a particular case of recognition. This paper examines whether the EU acts consistently with international law and EU law in engaging with Kosovo statehood, and to what extent EU law may influence bilateral relations between Member States and third States, considering the principle of sincere cooperation. The relationship between Kosovo and the EU may redefine the latter’s ability to actively contribute in solving territorial disputes in the context of the EU enlargement policy. This implies a strict respect for international law in accordance with Articles 3(5) and 21(1) TEU. Ultimately, despite State recognition being a prerogative of the Member States, the unity and consistency of the EU external action are potentially at stake.
