1. Premise

The hereby document intends to showcase both the activities and results of **the third edition (2024-2025) the Jean Monnet Chair in ‘Promoting Public Awareness on Enlargement Policy, EU Values and the Western Balkans’ Accession** (EUVALWEB), illustrating organizational aspects, such as social media engagement and usage, collaborations with other universities, institutes and Jean Monnet actions, composition of participants, and the proper outcomes/outputs ensuing from the Chair’s efforts.

Co-funded by the European Commission, Jean Monnet Chairs are specialised teaching posts for university professors, aimed at deepening teaching and research in European Union studies and fostering dialogue between academia and society, both in the Member States and in other Countries. **First presented to the audience in September 2022 and formally in November 2022**, the Jean Monnet Chair EUVALWEB is the continuation and improvement of the Jean Monnet Module '*EU-Western Balkans Cooperation on Justice and Home Affairs*' (EUWEB), active in the 2020-2022 period. The **Chair is held by Prof. Teresa Russo**, Associate Professor of European Union Law at the Department of Legal Sciences, University of Salerno, also responsible for the then Jean Monnet Module EUWEB.

The main goal of the Jean Monnet Chair EUVALWEB is highlighted and explained the important impact that the **EU Enlargement** policy has in the construction of EU identity based on its core values, as well as the EU strategy toward the Western Balkans, specifically in the field of Cooperation on Justice and Home Affairs (JHA), that is at the core of EU and Member States legal system, as well as beyond the EU's territory. To this end, alongside the Chair Holder, a gender-equal team of experienced and young advisors and trainers/teachers – the **Team Chair** – composed of national and international academics, policy-makers and professionals, carried out the teaching, research and dissemination activities envisaged in the Project.

Based upon the results achieved in the previous editions, the **third edition** of the Jean Monnet Chair EUVALWEB intended to **consolidate its offer** and **further expand its didactic, scientific research and professional training activities**, carrying out its initiatives throughout the academic year, both in Italy and abroad, in order to multiply the participation opportunities open to all categories of stakeholders; offer maximum dissemination of the activities and results achieved with the active involvement of public and civil society; further diversify activities in order to ensure the highest quality and topicality in the teaching of EU law.

For the third edition the main educational, professional and scientific activities were articulated, on one hand, in the EUVALWEB Chair Course convened within the EU Law course at the Department of Legal Sciences of the University of Salerno, in a specialized **teaching course** of the Department of Legal Sciences of the University of Salerno, **entitled ‘European Union Values, Integration and Migration Law’** with the recognition of 8 (eight) ECTS.

On the other hand, the Chair relied upon **two law clinics**, respectively: 1) '**EU Cooperation on Justice and Home affairs: Knowledges**', with the recognition of 2 ECTs (October-November 2024); 2) '**EU Cooperation on Justice and Home Affairs: Insights**', with the

recognition of 2 ECTs (April-May 2025), that are **established as practical and continuous courses** in the training offer of the Department of Legal Sciences of the University of Salerno. The present report will, in the first instance, shed light on Digital support and deliverables (**Section 2**), explaining how the use of technology is critical to advertise and manage the activities of the Chair. Also, it will illustrate the status of partnerships and collaborations, with specific attention given to newborn agreements (**Section 3**). The report will take into account every activity carried out since late 2024 within the third edition of EUVALWEB (**Section 4**). The composition of the participants enrolled, and their feedback, will be under the spotlight too (**Section 5**). Conclusively, the report covers the research activities carried out within the Chair and its scientific results and publications (**Section 6**).

2. Digital support and deliverables

2.1 Logo and recognizability

EUVALWEB's logo represents the atom (from the Greek *ἄτομος*, *átomos*: indivisible) because the Union must be indivisible, translating an idea of unity, tolerance and cooperation in overcoming the differences, as values deeply endorsed by the Chair, which is more than ever required in the current tight situation throughout Europe. The logo comes as an evolution of the one from 2020-2022 EUWEB Module and is consistently employed in a number of activities "EUVALWEB branded", performing an advertising function in the Chair and the partners and supporters' events, similarly to those scientific publications. The use of EUVALWEB's logo was punctually combined with the EU's flag, proudly reminding the nature of the project and the support of the European Union, as well as with the Italian Ministry of Foreign Affairs and International Cooperation's logo, which has given its sponsorship to the Chair since the first edition.

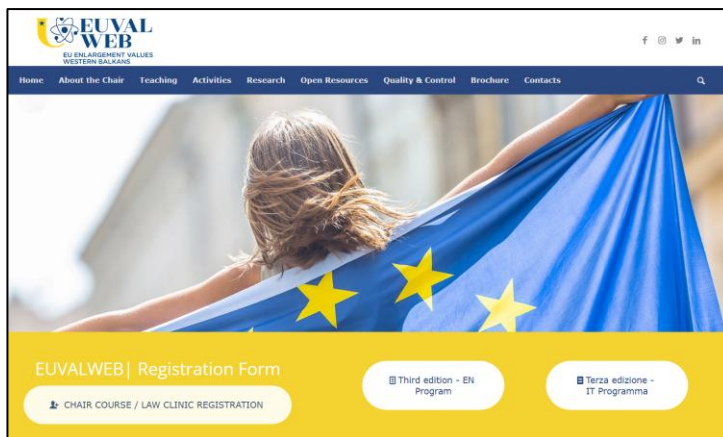


Horizontal logo variant

2.2 Website & email service

2.3 Brochure(s), flyers and media coverage

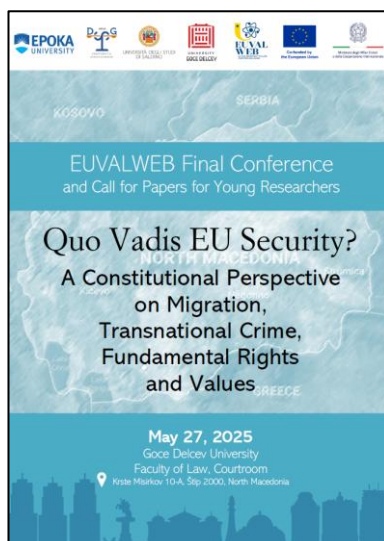

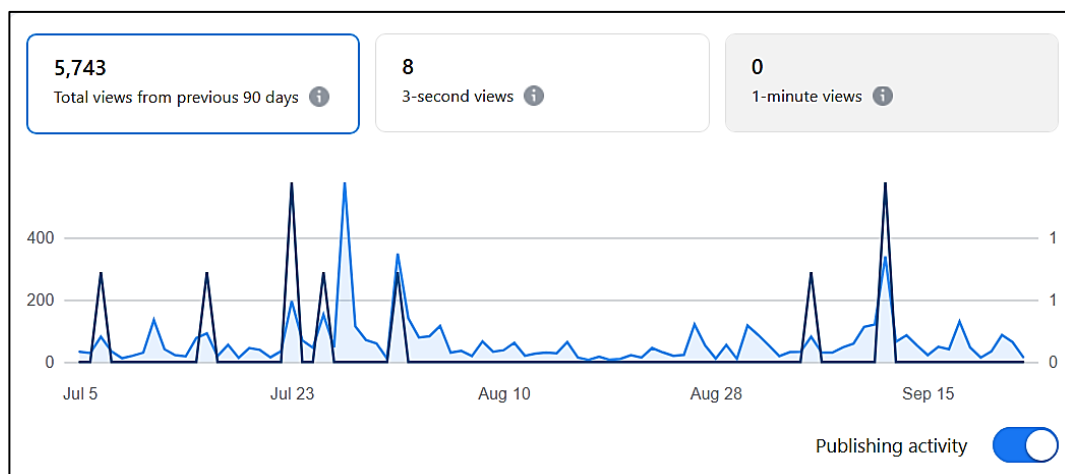

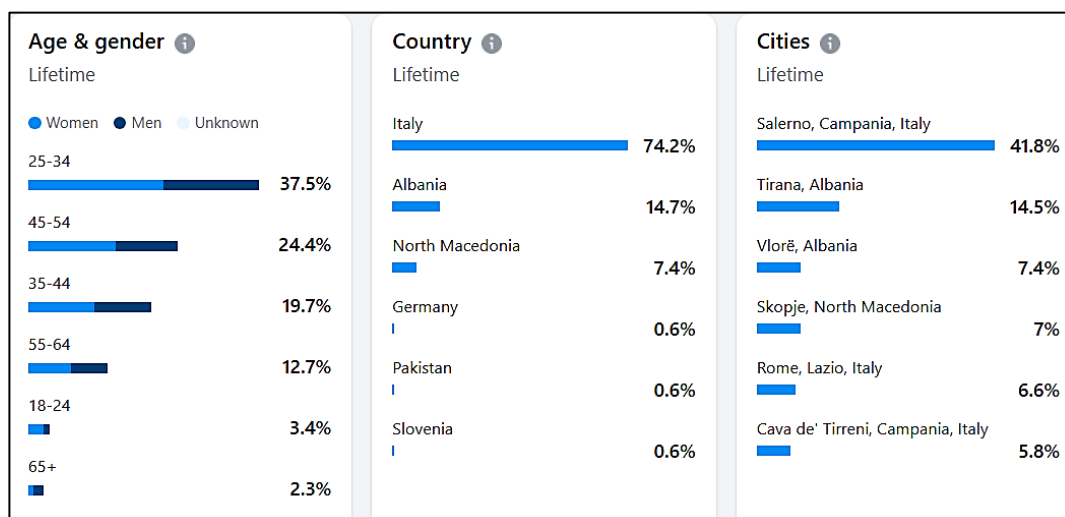
2.4 Social media engagement

3. Chair's Network and Collaboration Initiatives

3.1 'A Network of Security' in Europe with National Association of Magistrates, the Italian Postal Police, the Giffoni Experience Autonomous Body

During the Chair's third edition, the EUVALWEB Chair continued to pursue the project 'A Network of Security' in collaboration with the **National Association of Magistrates** –

Salerno District Section, the **Italian Postal Police**, the **Giffoni Experience Autonomous Body** and the **Bar Association of Salerno**.

The **goal of the project** is to promote, on a national and international level, a digital education that respects people's fundamental rights, highlighting, particularly for younger generations, the criminal implications of social network use and fostering the exchange of best practices and skills in the field of criminal judicial cooperation between operators.

The project has so far led to convening an event **at the University of Salerno in April 2025**, namely a **mock trial** on the subject of sextortion. **Additionally**, as part of the program of the **fifty-five edition of the Giffoni Film Festival** (July 2025), a special event on **Cinema and Law** was organized in order to raise awareness among young people of the proper use of social media, crime prevention, and knowledge of the law. The event saw the broad **participation of civil society and the local authorities active in the sector** – the Prefect, the local Police Chief, the Office of the Prosecutor – and was supported by **local companies** such as **Convergenze srl**.

This was attained too in another **event**, held in **Stip, North Macedonia** (May 2025). In particular, by convening such event **in conjunction with the Goce Delcev University**, the Chair recognizes the **significance of discussing the topic of digital security** with the **youth from acceding States**, where the discussion was enriched by words of **H.E. Paolo Palminteri, Italian Ambassador to Republic of North Macedonia**.

3.2 Team Chair

The EUVALWEB Chair promoted innovation in teaching and research through cross-sectorial and multi-disciplinary studies, open education, networking with other public and private institutions. During the third edition, EUVALWEB **Team Chair**, composed by Prof. Ivana **Bodrožić** (University of Criminal Investigation and Police Studies of Belgrade, Serbia), H.E. Remarkably, the **Goce Delcev University of Štip** offered the venue for the International Conference '*Quo Vadis EU Security. A Constitutional Perspective on Migration, Transnational Crime, and Fundamental Rights and Values*' of 27 of May 2025, which was also conceived as one of the two **final conferences** of EUVALWEB's third edition. The Chair had also the occasion to welcome **two Ph.D students** from Goce Delcev University, **Roze Surlovska Ristevska** and **Elena Trajkovska**, to the **EUVALWEB Legal Observatory** at the Department of Legal Sciences of the University of Salerno for a **two-week training**. This was also to allow the **exchanging of methods and approaches** to scientific research in the field of EU law with the Ph.D students from the University of Salerno's Department of Legal Sciences, on 12 May 2025, and foster their **participation to a Seminar** on the topic **corruption**, on 20 May 2025, and.

The first final conference was **co-organized with the EPOKA University of Tirana** too. The Albanian institution **proved a decisive partner in late 2024** as a meaningful part of the **EUVALWEB mission in Albania** involved the participation to initiatives organized with the help of the EPOKA University, ensuring a meeting with all the Chair's partners as well as a triplet of Conferences. In particular, **Conference for the planning of the activities of the 3rd edition** of the Chair, also with the participation of partners from North Macedonia (12 November 2024, morning), the **Conference to present the scientific results achieved** (12 November 2024, afternoon) and the International Conference '*Strengthening of Judicial Cooperation in Criminal Matters in the Light of EU Enlargement*' (13 November 2024), organised by the Jean Monnet Module WB-EUPath, were **all held at the facilities of EPOKA**.

In the same fashion, the Chair, **Prof. Teresa Russo**, was part of the **scientific committee** in the Call for Papers disseminated for the **XIV International Scientific Conference 'Archibald Reiss Days' of 7-8 November 2024**, convened by EUVALWEB's Partner, University of Criminal Investigation and Police Studies of Belgrade. **The Chair was also part to the event** to hold a **speech** during the **Plenary Session moderated by Prof. Ivana Bodrožić**, Member of the EUVALWEB Team Chair, as also reported by the **media coverage of the Serbian institution** and portrayed in the **pictures of the day**.

On top of that, the **University of National and World Economy of Sofia**, was the key stage for the International Conference '*The EU-Anti Corruption Framework in the Making*' of 9 June 2025, also broadcasted as a Webinar under the **Erasmus+ Project KA220-HED**.

Nonetheless, the Jean Monnet EUVALWEB Chair has built up **its collaborative network with other Jean Monnet activities**. Namely, the Chair sported cooperation with: the Jean Monnet Module '*Democracy and the Rule of Law: A New Push for European Values*' (**EU-DRAW**) – from the Department of Legal Sciences (School of Law) of the **University of Salerno (Italy)**, held by **Prof. Rossana Palladino** and also a Member of the EUVALWEB Legal Observatory, in **jointly convening** the Seminars '*Cyber-Security Trends and Legal Issues in International and European Law*' of 4 October 2024 and '*Cyberspace Facing*

the Challenges of Security and Artificial Intelligence of 28 November 2024; the Jean Monnet Chair *'Reinforcing EU responsible global leadership: promoting human rights and democracy through solidarity for a rules-based multilateral world'* ([ProSoEULaw Abroad](#)) from the Department of Law at the **University of Pisa (Italy)**, with **Prof. Leonardo Pasquali** as Chair Holder and also Member of the Team Chair as well as Member of the EUVALWEB Legal Observatory; the Jean Monnet Module on *'EU Integration of Western Balkans: Patterns and Issues'* ([WB-EUPath](#)) under the coordination of the Center for European Studies of the **'EPOKA' University of Tirana (Albania)**, with **Prof. Jubjana Vila** as Module Leader.

Additionally, the [dissemination of the Call for Papers](#) about the *'III Interuniversity Seminar on the European Union'*, 12 March and 15 May 2025 represented a moment of relevant co-operation with the Jean Monnet Chair *'Strengthening the European Union by Reinforcing its Values'* ([ReinforceEU](#)), from the University 'Miguel Hernández' of Elche (Spain) and held by **Prof. Elena Crespo Navarro**. Also at academic level, the Chair jointly convened with [Osservatorio sullo Spazio Europeo di Libertà, Sicurezza e Giustizia](#), with **Prof. Angela Di Stasi** as Director, the book presentation event *'The European Union in European and International Chaos: What Future for a Supranational Organization?'* of 17 March 2025.

At **high school level**, the Chair has seen the participation to its **workshops** by the North Macedonian **'Slavco Stojmenski' High School of Štip** under the mentorship of **Prof. Emilija Naunova** (29 May 2025) and the Italian **'I.I.S. Genovesi-Da Vinci'** and **'Istituto Professionale Servizi per l'Agricoltura e lo Sviluppo Rurale'** of Salerno (30 April 2025).

3.5 Supporters

As anticipated (Section 3.1), the **project 'A Network of Security' in Europe** allowed the Chair to continue scientific and social initiatives with the **Giffoni Film Festival**, directly involving Dr. Pietro Rinaldi (Head of the Giffoni Film Festival) and Dr. Jacopo Gubitosi (General Director Giffoni Film Festival).

The Chair also benefits of a **stable and qualified network of supporters**, namely: **'Avvocato di Strada'** NPO, Bar Association of Salerno, European Association International Studies (AESI), European Law Students' Association (ELSA), Italian Federation for Human Rights (FIDU), School of Magistrates of Albania, Superior Council of the Judiciary of Italy (CSM), NGO LEGIS; Macedonian Young Lawyers Association (MYLA), Association for Juridical Studies on Immigration (ASGI). For instance, the **Salerno Bar Association Council** granted the **recognition of professional credits** at the conference of **9 May 2025**. Specifically, during its third edition, the Chair had the privilege to **benefit from the presence and expertise** of: Agostino Allegro (Bar Association of Salerno), Teodora Kostadinovska Kjoseva (MYLA), Amarilda Lici (ASGI) and Alberto Toriello (Bar Association of Salerno).

Moreover, the third edition's schedule allowed EUVALWEB to gain sponsorship from official institutions and stakeholders and for specific events. Such was the case of the **United Nations High Commissioner for Refugees (UNHCR)** and the **International Organization for Migration (IOM)**, as well as the non-profit organisations **Arci**, **Dedalus** and **FuoriTratta** for the event '[Trafficking in Human Beings: Legal Framework and Critical Application Issues](#)' of 9 May 2025.

This was only **first event of the implementation protocol** on training concerning trafficking and exploitation concluded with **the Court of Salerno, and with the participation of Dedalus, IOM, EUAA, UNHCR** – which falls within the activities of the **EUVALWEB Legal Observatory**. Indeed, thanks to the **joint efforts of Prof. Teresa Russo and Dr. Francesca Iervolino**, EUVALWEB was able to secure a key partnership with these institutions, involving relevant stakeholders as listed above. The partnership aims to strengthen cooperation by establishing **training and orientation programmes** for students, designed to support them through both their university studies and their post-graduate careers. The agreement also includes **advanced training initiatives**, such as seminars, conferences, and cultural activities open to the public. These will be developed together to foster a **shared reflection on the cultural and educational needs of both students and professionals** involved.

The n.p.o. **Migrantes** was instead a key actor for the seminar '[**The Right of Asylum Report 2024 – Peoples on the Road... Without the Right of Asylum**](#)' of 28 March 2025, in the persons of Antonio Romano and Cristina Molfetta, as much as the **Council of the Peoples of Salerno**, in the person of Antonio Bonifacio.

4. Activities

The Jean Monnet Chair EUVALWEB was conceived as a **fundamental teaching course** and a **highly specialized training course** addressed to students, graduates, PhDs and PhD candidates, but also to all private and public stakeholders in the field of justice and home affairs, such as lawyers, policemen, public administration employees, etc. Due to the **diversification of targets**, EUVALWEB **opted to distinguish its activities in two different programs**, the **Chair Course** and the **Law clinics**.

4.1 European Union Values, Integration and Migration Law

The '[European Union Values, Integration and Migration Law](#)' course was **instituted in 2023 as a supplementary compulsory subject** in the 5-years unique curriculum available at the Department of Legal Sciences (School of Law) of the University of Salerno.

The course is set for **72 hours** in the **Second Semester** (February-June 2025) and grants **8 (eight) ECTs** in case of a successful final exam. Inserted in the GIUR-10/A of the

academic fields and disciplines list, this teaching aims to provide students with an in-depth **knowledge** of European Union **policies concerning the promotion and safeguarding of common values, integration and immigration and asylum**.

It relies on the explanation of **regulatory instruments and strategies** developed by the **European Union** in relation to the **accession of new Member States**, with specific reference to the requirements concerning the **control of external and internal borders** and the **conditions of entry and stay in the union of foreigners**, measures to combat irregular immigration, the treaty of human beings and the EU asylum and international protection system and regular migration, in the context of the construction of a European Area of security and justice founded on respect for and promotion of common values.

4.2 EUVALWEB Chair Course

The [EUVALWEB Chair Course](#) '*Enlargement, Values and Integration into the EU*' was intended to **target, above all undergraduate students**, and secondly graduates, Ph.D. and Ph.D. candidates, legal operators, judges, lawyers, law enforcement officials, civil servants and civil society representatives, policy makers. Held in the **Second Semester** at the **Department of Legal Sciences (School of Law) of the University of Salerno**, the Chair Course **lasted from March to April 2025, with the [inaugural lecture](#) held on 3rd of March**. The activities were carried out **in presence**.

As a stand-alone course by the Chair Holder, it was linked to other courses taught by the same Chair Holder to ensure the greatest possible participation. This was managed in particular with respect to the course of EU Law.

The **scientific direction** of the EUVALWEB Chair Course was in the hands of the **Chair Holder**, Prof. Teresa Russo, **assisted by the Chair Course Tutors**, Dr. Stefano Busillo and Dr. Emanuele Vannata. The course **aimed** to provide an **in-depth and detailed understanding** of the **European integration process** through the **lens of enlargement** and the development of the Union's **identity** based on the **founding values**. It took place in the **form of Lectures, Seminars, Conferences and Workshops**, with theoretical/practical and problem-solving approaches.

The **workshops** were intended to be the **finalization** of each of the **four (4) distinct modules** in which the **Chair Course** was organized into, as specified below:

During the Course, **trainees**, divided into small groups, under the supervision of the Chair Holder and with the support of Tutors, **carried out four interactive workshops** for the elaboration of **papers** in the form of **questions** and possible solutions, then discussed at one of the closing conferences of the Chair. **Representatives** from the **workgroups** were asked to study topics of their selection in order to **showcase their knowledge** in the **second final Conference of the third edition, on 18 September 2025**. They were also **tasked to include critical remarks in the form of queries** so that their questions could be **properly addressed** in the same Conference. This was to assess public perception of the European Union and opportunities for integration.

4.3 Law Clinics

In 2023, **two law clinics established as new practical courses** yearly available in the training offer of the Department of Legal Sciences of the University of Salerno. Both clinics

are qualified as **lab activities** in the 5-years unique curriculum of the Department and do **grant 2 ECTS**.

The [agenda](#) of the EUVALWEB Law Clinic '[EU Cooperation on Justice and Home Affairs: Knowledges](#)' takes place in the **First Semester** and intends that the students **acquire the basic knowledge of the current European area of freedom, security and justice** with a practical approach related to the origins of cooperation and its evolution up to its formalisation in treaties as well as the different forms of integration and cooperation. It also covers the EU policies on border controls, asylum and immigration, judicial cooperation in civil and criminal matters and police cooperation, with specific reference to the acceding States

The EUVALWEB Law Clinic '[EU Cooperation on Justice and Home Affairs: Insights](#)' takes place in the **Second Semester** and aims to **deepen the characterising elements of the European Union's cooperation on justice and home affairs**. It provides students with advanced knowledge and insights concerning the current area of freedom, security and justice, with a practical specifically dedicated to the study of cross-border security issues, the fight against transnational crime, of police and judicial cooperation, the promotion of the union's values and the protection of fundamental rights, with specific reference to the acceding States.

The activities were held by the Chair Holder, academics, legal professionals, policy makers, civil society representatives and NGOs. Differently from the Chair Course, the Law clinics also **offered in-depth teaching** on European Union **issues for future professionals** specializing in cross-border issues that are increasingly in **demand in the labour market**. The final selection of topics included: immigration, cross-border security, combating transnational crime, police and judicial cooperation, and the promotion and protection of EU values and fundamental rights.

4.4. Conferences, Seminars, Workshops & Other Activities

Conferences referred to as a huge formal typically involved a larger gathering of participants, covering a **broad and diverse range of topics**, often from different disciplines. Their type of work was based on, first, presentation and, second, debate/exchange of views. The consultative nature of the Conferences made them the natural venue to further the research and find solutions to the prospected problems.

In its third edition EUVALWEB hosted **a total of five Conferences** as follows.

5. Participants' composition, feedback, credits and certifications

5.1 Composition

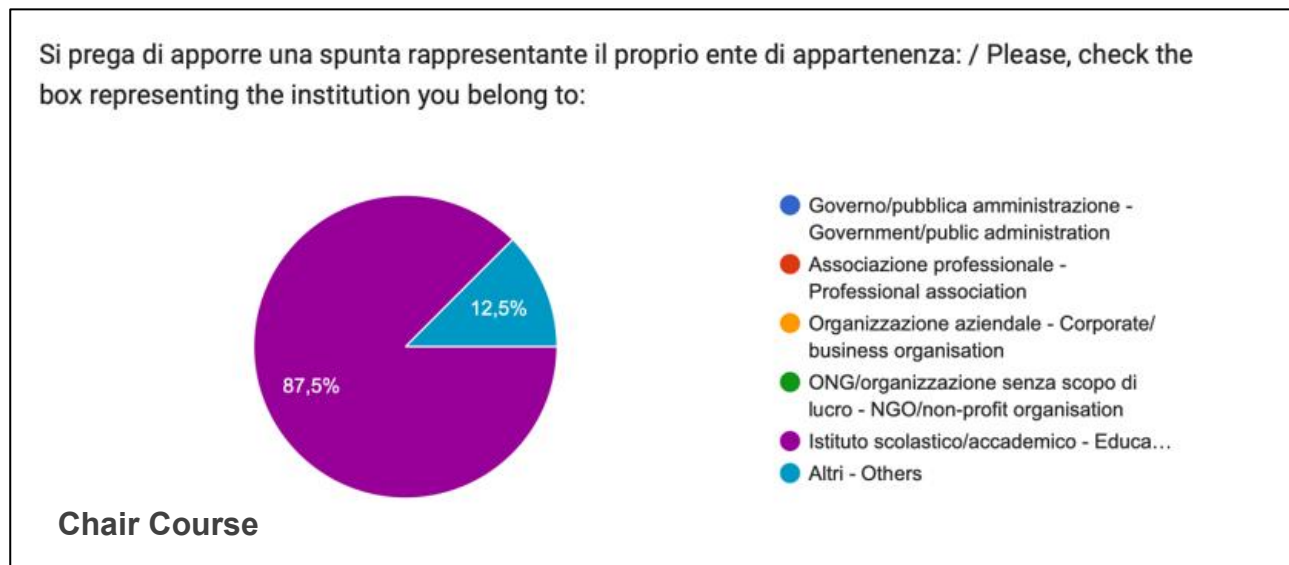
Participating to any of the Chair's activities was **free of charge** and participants **needed only to register** on the Home Page of the website '<https://euvalweb.euweb.org/>', by clicking the [registration button](#), **alternatively or cumulatively, for the Chair Course or LawClinics**. For the latter, **participation to a single event** (e.g. Conference) was likewise **permitted** through registration on the website. The acknowledgement of credits and certifications for both students and professionals were directly related to the chosen activity.

Attendance was **recorded** during the events, asking the attendees to **sign** twice, at the moment of their arrival and before leaving. Attendance recording was key in order **to assert** if an attendee would be **eligible to earn credits** or the final **certificate of attendance**. These were granted to each participant that attended at least **70% of the total lectures of the Chair Course** or **50% and a written test in the Law Clinics**. The events were **open to the participation of everyone interested**, with no particular requirements for the registration or, eventually, no need for registration to attend the event. Also, the Chair adopted a **flexible approach** in providing the possibility of **participation to single events** to those who purposely registered for them.

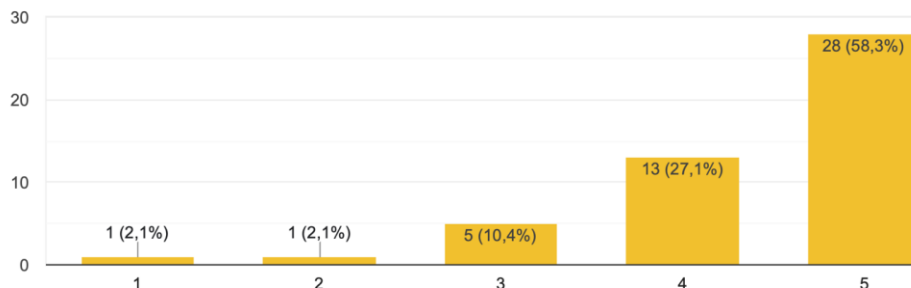

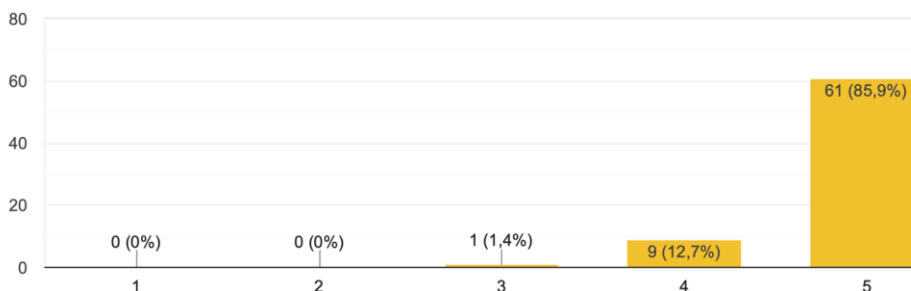

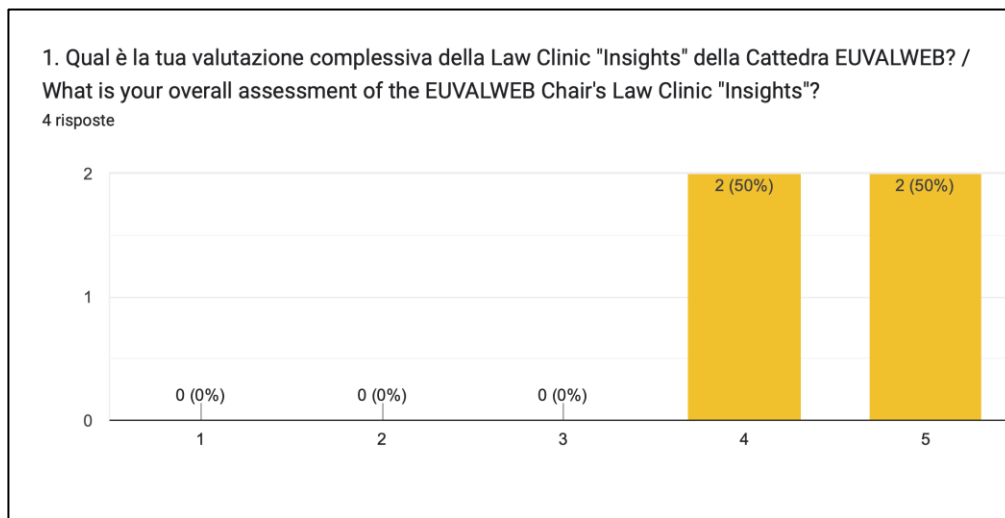
Chair Course's overall assessment.

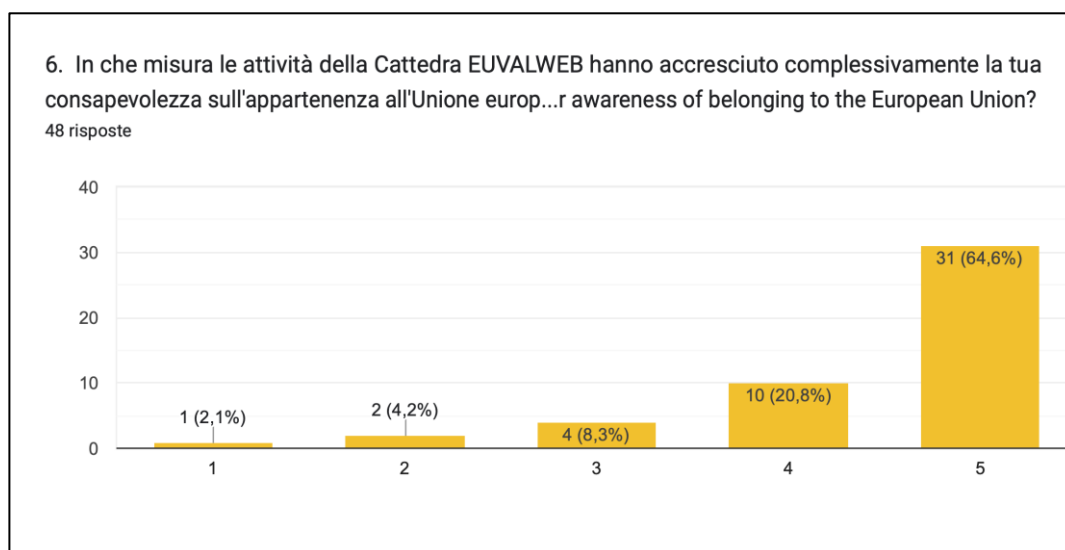


Law Clinic: Knowledges' overall assessment.
(ratings from 1 = very bad, to 5 = very good)

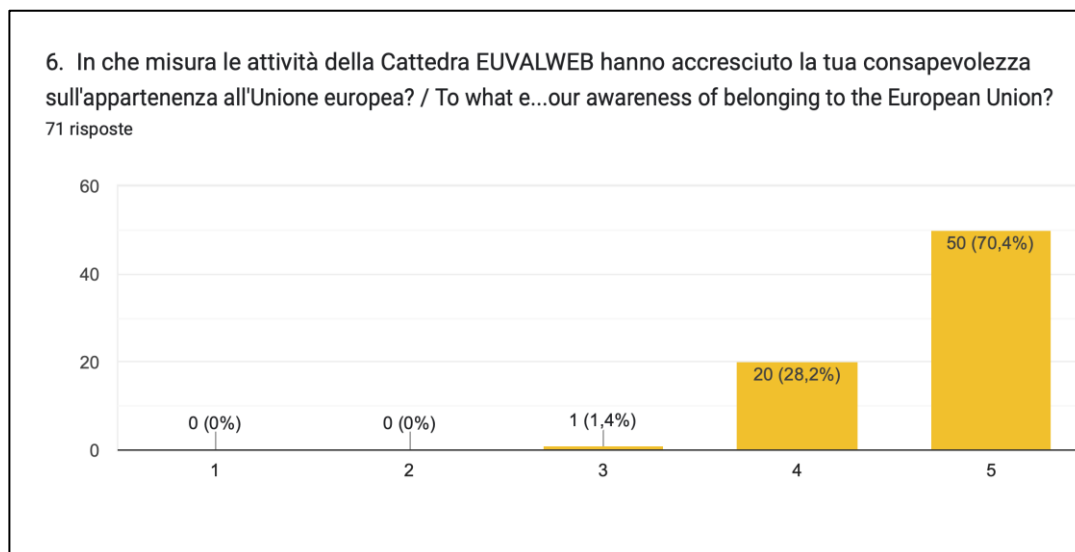


Law Clinic: Insights' overall assessment.
(ratings from 1 = very bad, to 5 = very good)

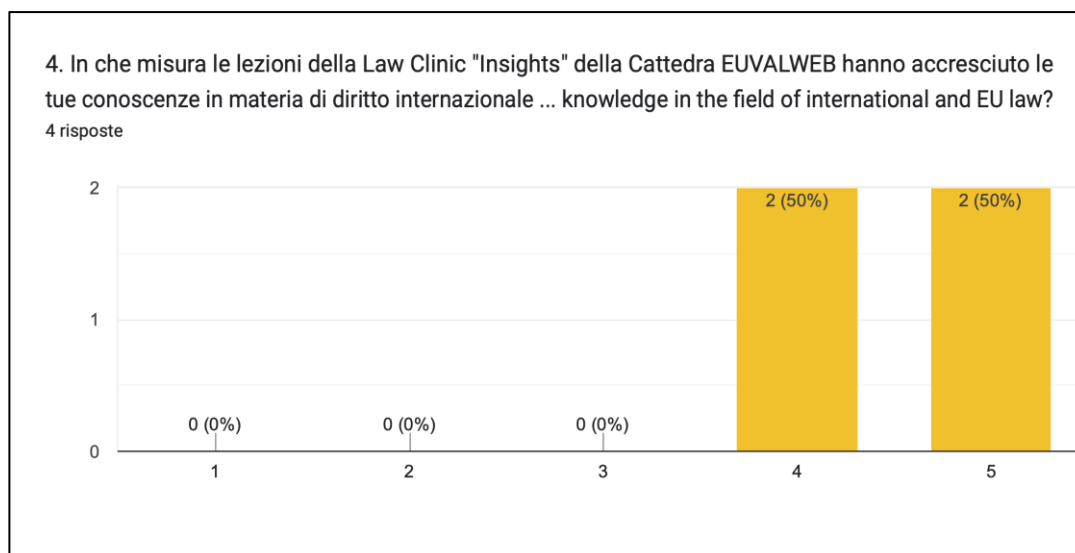

5.3 ECTs for students, credits for practitioners and certificates

In both the **Law Clinics**, in order to gain **2 (two) ECTs**, all the **enrolled undergraduated students** were invited to **submit a final test** on the topics covered during the training activities of the Clinics themselves, whereas students enrolled in the exam '**European**

Union Values, Integration and Migration Law that successfully took the exam were recognized of **8 (eight) ECTs**.

Not only that, the Department of Legal Sciences of the University of Salerno decided to **recognize 1 (one) ECT** under art. 10, para. 5, let. b), of Ministerial Decree 22 October 2004, No. 270, for those UNISA **students** that were regularly enrolled and **took part in the special event ‘Cinema and Law’ of 23 July 2025**.

As anticipated, **lawyers** participating in the activities of the **Law clinics** were awarded a number of professional training credits (CFP) by the Salerno Bar Association Council for the event of 9 May 2025. The **remaining stakeholders** updated their training and professional background with the **recognition of professional training credits**.

The enrolled participants that achieved **70% (Chair Course) or 50% (Law Clinics) of attendance** were awarded a **certificate**.

6. Research and publications

6.1 Volume *‘Quo Vadis EU Security? A Constitutional Perspective on Migration, Transnational Crime, and Fundamental Rights and Values’*

The **final conference** “Quo Vadis EU Security? A Constitutional Perspective on Migration, Transnational Crime, and Fundamental Rights and Values”, held at Goce Delcev University in Stip (North Macedonia) on 27 May 2025, aimed **to assess the adaptation of the accession States’ legal systems to the membership criteria**, addressing the Union’s security in the sphere of cooperation in Justice and Home Affairs (JHA).

In particular, it **mapped the constitutional dimensions of the European Union’s evolving security architecture along three intersecting vectors**: (i) migration and asylum governance, including the shifting balance between control and protection; (ii) the

fight against transnational crime and the protection of the EU's financial interests; and (iii) the safeguarding of fundamental rights and values in Candidate and Member States.

Hence, the [subsequent collected works](#) of the Conference, **edited by Teresa Russo, Ana Nikodinovska Krstevska, Olga Koshevaliska, Niuton Mulleti** and published by the Goce Delcev University, highlight the **main critical issues encountered in these sectors**, primarily in North Macedonia, but also in Albania and Serbia. The contributing papers comprise **concise doctrinal analysis, focused case studies, and policy-oriented essays** – each peer-reviewed and grounded in up-to-date sources – covering topics such as pre-entry screening and accelerated procedures, cross-border enforcement and judicial cooperation, and rights-based safeguards against securitization drift. Together, they assess implementation gaps, legal uncertainties, and institutional trade-offs, while proposing workable pathways to ensure coherence with the Treaties, the Charter of Fundamental Rights, and the *acquis*.

While the collection is the result of activities presented at said final conference of the Jean Monnet Chair, it **captures the continuous scholarly work of a dedicated research group over several years under the EUVALWEB Legal Observatory**. The volume thus crystallizes an ongoing research agenda that connects academic analysis with policy relevance and practice, offering a resource for scholars, policymakers, practitioners, and students engaged with EU integration and security in the Western Balkans.

6.2 EUVALWEB Legal Observatory and Young Observers

Deepening the cooperation with the Western Balkans Partners and widening the spectrum of scientific collaborations to other academic *fora*, the **EUVALWEB Legal Observatory** builds directly on the experience of the 'EUWEB Legal Observatory', which is linked to the activities of the 2019-2022 Jean Monnet Module '*EU-Western Balkans Cooperation Justice and Home Affairs*' (EUWEB).

The Observatory's current configuration **broadens its research area**, adapting to the needs of the Chair. Overall, the body [Members](#) share the purpose of enhancing collaboration and research in broadly **defined areas** of migration, fight against transnational crimes, police/judicial cooperation and EU values & Fundamental rights. Among the goals of the Observatory, it is fair to stress the **commitment to identify evolving trends** in the field of EU cooperation on **justice and home affairs** as well as to **raise awareness** of national, international and European **policies** to ensure security and respect for the rule of law, democracy and human rights at national and international level. In order to aptly carry out their [activities](#), during the third edition of the Chair, the Members of EUVALWEB Legal Observatory **met periodically to update about their research work and developments in International Law and EU Law**.

In 2025, the EUVALWEB Legal Observatory offered a [2-weeks program training](#) to **two doctoral students, Roze Surlovska Ristevska and Elena Trajkovska**, from **Goce Delcev University of Stip, North Macedonia**. The **traineeship** enabled the PhD. Students to engage with the core activities of the Observatory not only to **enhance their skills, but also** to make a **significant contribution to scientific initiatives** carried out by the Chair in May 2025 and to **publish their works** on a foreign journal.

In perseverance of a **bottom-up approach**, existent since the EUWEB Module, the Chair **temporarily included students** in the Legal Observatory, granting them the status of **Young Observers** – led by a **Supervisor, Dr. Elisabetta Lambiase**. The **2025 line-up** consisted of five members (alphabetical order):

The **Young Observers** were accordingly selected to conduct research of documents, sources and judgements as well as the elaboration of original work undertaken primarily to acquire new knowledge with a specific application in view. They were also **included in the activities of the Chair**, such as taking **part in the stewardship of the conferences** as well as the **reception of the guests** and the **management and support of the audience** during the **open debates**. On top of that, as anticipated, the Young Observers were **invited to update the audience** on the latest developments in the **second final Conference of 18 September 2025**, as well as to **take part the inaugural lecture of the Chair Course of 3 March 2025**.

6.3 EUWEB Legal Essays. Global & International Perspectives

[EUWEB Legal Essays. Global & International Perspectives](#) (ISSN: 2785-5228) was **born in 2022** from the then EUWEB research group's desire to make the most of and build on the scientific results achieved within the 2019-2022 **Module "EUWEB"**.

In addition, the review – [classified since 2025 as ‘scientific journal’ under the ANVUR criteria](#) - seeks to disseminate the research conducted, at this time, by the **EUVALWEB Legal Observatory** on a platform promoting the scientific work of scholars, practitioners, and stakeholders in the fields of EU and International Law, particularly in the relationship with the Western Balkans. The Journal, in full respect of its Ethical Code and Anti plagiarism Policy, **publishes two online issues per year** (winter and summer) of articles exploring particularly the external dimension of immigration, the fight against transnational crime, judicial and police cooperation, and the protection of fundamental rights, promoting a multidisciplinary approach in legal studies. EUWEB Legal Essays boasts some features, such as being:

- **Open access:** to guarantee the widest possible readership, the articles are available free of charge on the Journal’s website.
- **Peer-reviewed:** submissions undergo rigorous double-blind peer reviews by the Reviewing Committee that includes highly qualified members of the world’s scientific community.
- **Multidisciplinary:** committed to promoting a multidisciplinary approach in legal research.
- **Multilingual:** committed to promoting linguistic diversity by publishing articles in English, French, Italian, and Spanish.

6.5 Bulletin

The **Young Observers** were entrusted with the periodic publication of the **Bulletin**, which provides clear **insights into the current status of legislative and operative processes** regarding the [thematic areas](#) covered by the **EUVALWEB Observatory**. Giving out concise EU-related bundle information on legislative files or topics, the Bulletin publishers tried to act in a way to easily have the readers updated.

Bilingual news (EN/IT) are duly released in order to keep the **audience aware** of the **developments on key issues and policy areas** that have the potential to feature prominently in **public debate** and on the **political agenda of the European Union** over the coming years. In particular, the Bulletin was **keen on tracking the record of crisis management** on the major emergencies of the year, covering the Ukraine and the migration crises.

The Bulletin is available on EUVALWEB’s website (Open Resources) and is **edited** by the **Young Observers** with the **aid of their supervisor** with a precise assignment of the topics to look out:

6.6 Didactic Materials & Other

In the first place, EUVALWEB provided a set of [Didactic Materials](#) for both the **Chair Course** and the **Law Clinics**. The Chair envisaged its Didactic Materials as **wide variety of educational resources** and tools of subject-specific nature that are used as learning aids. Their mission is to ultimately **clarify the contents** and to achieve a **deep and meaningful understanding**. Out of users' choice, they **may represent auxiliary resources** that accompanied the speaker's explanations, in the case of **Seminars, Conferences and Workshops**, or as the **main resource** where to find **all the contents to be learned** on that occasion, as happened for the **Modules of the Chair Course**.

As an example of the variety of the Materials, the user may inspect the aforementioned **reports** from the **Young Observers** within the EUVALWEB Observatory as well as the **Proceedings of the student working groups of 18 September 2025**.

Other periodically updated open resources provided to the audience by the Chair, such as the **Bulletin**, are the so-called **essential references**. In particular, keeping up to date with the **current and future status** of the [Caselaw](#) is key in delivering the most up-to-date education. **Courts' decisions can affect everything** from the European States (requiring them to adjust a certain policy), the institutions of International Organizations or even individuals. Hence, Caselaw references become a **complementary tool for the correct understanding** of the topics covered by the Chair. Similarly, **legal doctrine** sets the terms for **future resolution of cases** in an area and not seldom offers to **rationalize** what the courts or the legislator finds **unclear**. In addition, **scholars** rely upon a **communication formula** that is purposefully **meant to "teach" or "inform" the reader**. For these reasons, [Bibliographical references](#) were included in the resources intended to aid the learners.
